NARRATIVE DESCRIPTION  
THOMAS W MCCORMICK SCHOLARSHIP FUND, CORP.

The Thomas W. McCormick Scholarship Fund, Corp., hereinafter “the company,” was incorporated on December 30, 2004 as a Florida non-profit corporation. Its primary purpose is to provide scholarships to deserving students to promote culture and learning. This program is designed to promote education, encourage people to experience other cultures, and enrich lives.

The following is an outline of the qualifications for students participating in the scholarship program:

- Students who receive a scholarship must become a member of the Thomas W. McCormick Scholarship Fund. The cost is \$25.00
- Students must be between 18 and 24 years old.
- Students must be actively enrolled in a study abroad program in an accredited College or University and provide evidence.
- Students must have an overall GPA of 3.2.
- Students must come from a family with sound values and morals.
- Students must have a record of being well disciplined.
- Students must be of sound character.

Upon receipt of applications, recommendations and biographies, a committee reviews each applicant with the process of eliminating those who do not qualify according to the criterion outlined above. Interviews will then be scheduled for the remaining applicants. Each student is required to sign a “consent form” and a “waiver of responsibility.”

**Selected applicants will receive scholarship of up to \$1,000 used to pay for their study abroad program fees.**

**Please note:** The McCormick Foundation will give preference to students participating in programs with a language component. Other programs will be evaluated on a case-by-case basis. Funds cannot be guaranteed.

When the students return from their study abroad, they provide board members with a report of their trip, what they have learned, both culturally and educationally, and photographs or a video of highlights of their trip.

Increasing Awareness of the Thomas W. McCormick Scholarship Fund, Corp.

A student ambassador club has been formed. The purpose of the club is to stimulate enthusiasm of students to volunteer time to “give back” to the community and increase awareness of the Thomas W. McCormick Scholarship Fund among our youth. The club is comprised of a President, a Vice President, and committee members. Various duties of the members might include, decorations and/or registrations for various fundraising

events, clerical help, and increasing communication skills with other countries. Upon accepting this scholarship, each recipient must agree to contribute their time in the student ambassador program before they travel abroad. This contribution can be in the form of attending Thomas W. McCormick sponsored events, assisting the Chairman of the Board with assistance in the office, and/or any other efforts deemed necessary to further the awareness of the Thomas W. McCormick Scholarship Fund. Ideally, the student should contribute at least 10 hours of service before their trip abroad.

In addition, the company will sponsor student ambassadors to attend regular socials open to both members and the general public. Two examples of these kinds of events include our “signature event” which is the annual Boat Parade Celebration held during the boat parade each year in December and other socials.

Services to “Members” of the Thomas W. McCormick Scholarship Fund, Corp

In order to further its mission the Company offers individuals several different membership opportunities. A central database is used to track each member’s membership. There are four levels of membership: students, individuals, family, and corporate. Student memberships are \$25.00 and include high school and college. Individual memberships are \$50.00 and are for one person living alone. Family memberships are \$85.00 and include a husband and wife or two partners living under the same roof. Corporate memberships are \$250.00 and include 3 employees of a corporation. Student and individual members are entitled to 1 vote. Family members are entitled to 1 vote. Corporate members are entitled to 3 votes.

The Company will maintain a centralized database updated on a regular basis, which provides an accurate record of the members, their membership status, current contact information and membership date.

Additionally, a website was created so that the members will have access to planned activities. Member services and benefits will primarily be conducted through Vice President/Committee of Membership. All contributions from professionals, corporations, and other donors will be used to further the goal of the Thomas W. McCormick Scholarship Fund, Corp.
